- Performances limited to 3 minutes each.
- All participants must be legal residents of Wisconsin
- Suggested basic talent areas: Dance, Vocal, Instrumental, Variety
- Two age divisions: Youth (2-12 yr.), Teen (13-18 yr.)
- Prize Money awarded for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> in each age division in the amounts of \$75,
  \$50 and \$25, respectively.
- ✤ No more than 5 participants in an act
- No combos, rock bands or similar groups permitted.
- All submissions must be uploaded to YouTube with an attached link in the submission form or sent via email or other video upload to the fair office by 5PM on Monday, July 6.
- All performers must print out and have the "Jefferson County Fair on Tour" poster visible in their video submission to ensure that submissions are current and real.
- ✤ All performances will be aired on our Facebook page starting at 5:30PM on Wednesday, July 8.

## 2020 Jefferson County Fair "Virtual" Junior Talent Competition Contestant Rules

- 1. Competition is open to legal residents of the state of Wisconsin only.
- 2. Judge's decisions are final.
- There are two divisions for entry please submit your age with your registration form. Youth: 2 through 12 years Teen: 13 through 18 years
- 4. Youth acts will be permitted to have one performer who is 13 years old only. If a performer in a Youth act turns 13 before the Jefferson County Fair, thus making the Youth act have two or more 13-year-olds, that act will automatically become a Teen act. <u>Any performer who is 14 years or older will not be allowed to perform in a Youth act.</u>
- 5. Acts are required to keep the performance at three minutes or less. Acts running longer than three minutes are subject to possible disqualification or point deduction. This will be at the judge's discretion.
- 6. No more than five persons are allowed in an act. Accompanists are not considered part of the act and can be of any age. Please limit the number of accompanists to three.
- 7. Acts are asked to introduce themselves and what they will be preforming. After introductions, contestants may take any position they wish to begin their performance.
- 8. Contestants may only appear once in any given show. They may not perform "solo" and then return in the same show in a duet or trio.
- 9. Professionals are NOT permitted to compete. This includes Union musicians and anyone whose <u>principle source of income is from their talent.</u> Compensation for performing at weddings, etc. does not constitute principle source of income.
- 10. Acts will need name, complete address, birth date, age, phone number (include area code), and type of talent. Acts with multiple contestants need one member to act as a contact person, and all information will go through them. Additional members of the act need only name, birth date, age and town.
- 11. Performers will be required to have the "Fair on Tour" poster visible in their performance submission.
- 12. By submitting this registration, you agree to the Jefferson County Fair Park using your video for promotional materials on their website and social media pages.
